# 1. Outline

Today, **spatial planning is affected by a series of trends** such as the increased availability of data sources and new forms of data processing, the emergence of new voices ranging from community leaders to large technology companies hosting 'sharing economy' platforms. At the same time, governments are trying to reinvent themselves by employing new soft policy instruments and network governance models. These trends can be considered as **both challenges and opportunities** for the many challenges spatial planning seeks to address, such as managing the transition to a green economy, keeping cities prosperous, just and liveable, and promoting sustainable urban development.

The ESPON conference on "Spatial Planning in Western Europe: Current trends, policies and research" addresses this core questions by:

- Looking into the content, design and implementation of the new National Spatial Strategy in The Netherlands;
- Reflecting on relevant results from ESPON research projects on territorial patterns of ecosystem resilience, such as green infrastructure networks and sustainable land use;
- Taking stock of the discussions held during the previous editions of the roadshow in France, Ireland, Belgium, and Luxembourg in 2018;
- Finding inspiration in sharing our experiences in different European countries.

The afternoon design-thinking lab will be facilitated by Sensetribe: participants will contribute to a collaborative brainstorming session on some of the core changes which are affecting the spatial planning culture in Western Europe today. The outcomes will be presented in the presence of the Director of Spatial Planning of the Ministry of Interior and Kingdom Relations.

This ESPON conference is one of a series of Transnational Outreach events organised in Western Europe in 2019. It comes as the final edition of a roadshow which included national editions in France, Ireland, Luxembourg and Belgium.

# **GRETA – Green infrastructure: Enhancing biodiversity and ecosystem services** for territorial development

Green Infrastructures (GI) are considered a benefit, inter alia, for territorial development because they provide multiple functions on the same spatial area. The underlying principle of GI is that the same area



of land can offer many environmental, social, cultural and economic benefits at the same time, provided its ecosystems are in a healthy condition. However, valuable European ecosystems are being degraded by land fragmentation, urban expansion and the building of transport and energy infrastructures. This affects habitats and species and reduces the spatial and functional coherence of the landscape. Degraded ecosystems have lower species richness and are unable to offer the same services as healthy ecosystems. Ecosystem services cover the benefits that can be derived from ecosystems, including among others the provision by nature of food, materials, clean water, clean air, climate regulation, flood prevention, pollination and recreation.

# SUPER – Sustainable Urbanization and land-use Practices in European Regions

Land is a finite resource and the way it is used is one of the principal drivers of environmental change. Increasing land take affects fertile agricultural land, puts biodiversity at risk, increases the risk of flooding and water scarcity and contributes to both the causes and effects of global warming. Moreover, the effects of land take differ depending on the value, quality and functionality of the land. By building on existing key relevant studies and projects, the research suggests measures on how sustainable land use can be promoted and how land-take, soil sealing and urban sprawl can be avoided, reduced and compensated in Europe, its cities and regions. The starting hypothesis is that a sustainable use of land would entail that compact and denser urban development would lead to less need for transport, less energy use and more open spaces enhancing the quality of life thus generating benefits and requiring less costs.


